TO CONSIDER LONG-TERM DEBT FINANCING FOR THE CENTRAL LIBRARY RENEWAL PROJECT

The City of Regina hereby gives notice, pursuant to sections 101 and 102 of *The Cities Act* and *The Public Notice Policy Bylaw, Bylaw No. 2020-28*, of its intention to consider a report on long-term debt financing to fund the Central Library Renewal Project. The City will consider incurring debt in the maximum principal sum of \$119 million for the Central Library Renewal Project. The goal of the Central Library Renewal Project is to provide a renewed Central Library to respond to community priorities, enhance Regina Public Library programs and services, improve quality of life for all, and support economic growth.

The particulars of the report on the above item will be considered by **City Council** on July 9, 2024 at 9:00 a.m and may also be considered at subsequent meetings. Citizens who want to address **City Council on July 9, 2024** may attend the meetings via teleconference or in person.
