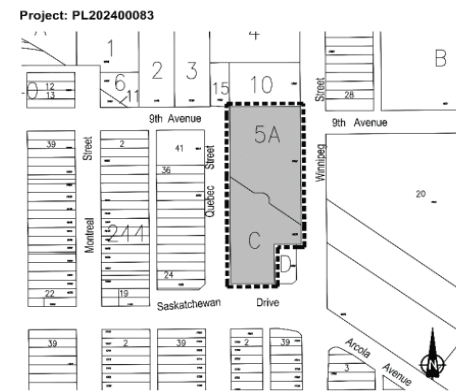

### TO CONSIDER LONG-TERM DEBT FINANCING FOR THE WATER NETWORK EXPANSION PROJECT (previously known as the EASTERN PRESSURE SOLUTION PROJECT)

The City of Regina hereby gives notice, pursuant to sections 101 and 102 of *The Cities Act* and *The Public Notice Policy Bylaw, Bylaw No. 2020-28*, of its intention to consider a report on long-term debt financing to fund the Water Network Expansion Project (previously known as the Eastern Pressure Solution Project). The City will consider incurring debt in the maximum principal sum of \$200 million. The Water Network Expansion Project is required to provide a long-term plan for the City's water distribution network to accommodate growth. The implementation of the Water Network Expansion Project will allow the City to continue to meet the needs of current and future customers and target levels of service goals for development, safe and reliable service, regulatory compliance and environmental stewardship.
