

City of Regina Blue Cart Contest

Term

The City of Regina Blue Cart Contest begins on January 2, 2020 and ends on January 30, 2020. The first person to comment with the correct answer on each weekly post will win a prize.

Who May Participate

Participation is open to all individuals aged 13 and older, which is the minimum age required to create a Facebook account.

How to Participate

To participate in this contest, a Facebook user must answer the question in the comment section of the Facebook post.

The answer must not, in the sole and unfettered discretion of the City, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content. Any comment that is considered by the City to contain said content, in whole or in part, will be disqualified.

Submissions that, in the City's good faith judgment, violates the requirements set out herein will be disqualified. Submission must be received by the end of the term specified.

Prizes

There will be a total of five 'Zero Waste Starter Kit' prizes, one awarded for each contest.

The starter kit is valued at \$50. It consists of five City-branded produce bags, one City-branded lunch bag, two City-branded reusable and packable shopping bags, one City-branded cloth shopping bag, a Beeswax Food Wrap variety pack (includes three wraps), a reusable collapsible cup, a reusable straw cleaning brush and a stainless steel straw.

The Prize must be accepted as awarded and may not be substituted, transferred or redeemed for cash or otherwise. The City reserves the right, at its sole discretion, to substitute a prize of greater or equivalent monetary value if the Prize, or part thereof, cannot be awarded as described for any reason.

How to Win

The first person to answer the question correctly on each weekly Facebook post will win the prize. There will be five individual prizes, one awarded to each weekly winner, for a total of five weekly winners.

Prize Claim Conditions

In order to be declared a winner, the selected entrant must: (i) respond to notification of selection; (ii) sign a written declaration and release form, releasing the City from any liability in connection with this Contest or the use, misuse, awarding or possession of any prize (the "Release"); and, (iii) otherwise comply with these Terms and Conditions. Return of the Prize, or any part thereof, or winner notification as undeliverable, inability to reach selected entrant or failure of selected entrant to respond to notification within two (2) business days of first attempt by the City, failure to provide proof of eligibility (if requested), release documents, or other required documentation in a timely manner, or other non-compliance with these Terms and Conditions may result in disqualification, forfeiture of the Prize, or part thereof, and, at
